

Volunteer Release and Waiver of Liability, Non-Disclosure and Assignment of Rights Form (the "Release")

This Release is executed on the date set forth below, by Volunteer as defined below in favor of Breadcoin Foundation Ltd ("Breadcoin"), a nonprofit corporation, and its directors, officers, employees, and agents.

Volunteer desires to work as a volunteer for Breadcoin and engage in the activities related to being a volunteer for Breadcoin (the "Activities"). Volunteer understands that the Activities may include, but are not limited to, providing services (including physical labor) at outdoor events in various locations, handling food, engaging with the community at large, working with the homeless population and engaging in other public services opportunities offered through Breadcoin. Volunteer hereby freely, voluntarily, and without duress executes this Release under the following terms:

- 1. Release and Waiver.** Volunteer hereby releases and forever discharges and holds harmless Breadcoin and its successors and assigns from any and all liability, claims, and demands of whatever kind or nature, either in law or in equity, that arise or may hereafter arise from Volunteer's Activities with Breadcoin. VOLUNTEER UNDERSTANDS THAT THIS RELEASE DISCHARGES BREADCOIN FROM ANY LIABILITY OR CLAIM THAT VOLUNTEER MAY HAVE AGAINST BREADCOIN WITH RESPECT TO ANY BODILY INJURY, PERSONAL INJURY, ILLNESS, DEATH, OR PROPERTY DAMAGE THAT MAY RESULT FROM VOLUNTEER'S ACTIVITIES WITH BREADCOIN, WHETHER CAUSED BY THE NEGLIGENCE OF BREADCOIN OR ITS OFFICERS, DIRECTORS, EMPLOYEES, OR AGENTS OR OTHERWISE. VOLUNTEER ALSO UNDERSTANDS THAT BREADCOIN DOES NOT ASSUME ANY RESPONSIBILITY FOR OR OBLIGATION TO PROVIDE FINANCIAL ASSISTANCE OR OTHER ASSISTANCE, INCLUDING BUT NOT LIMITED TO MEDICAL, HEALTH, OR DISABILITY INSURANCE IN THE EVENT OF INJURY OR ILLNESS.
- 2. Medical Treatment.** Volunteer hereby releases and forever discharges Breadcoin from any claim whatsoever which arises or may hereafter arise on account of any first aid, treatment, or service rendered in connection with Volunteer's Activities with Breadcoin.
- 3. Assumption of the Risk.** Volunteer understands that the Activities may involve work that may be hazardous to Volunteer, including, but not limited to, lifting objects, exposure to weather, exposure to work sites and neighborhoods outside of Volunteer's own residential area, and transportation to and from the work sites. Volunteer hereby expressly and specifically assumes the risk of injury or harm in the Activities, and releases Breadcoin from all liability for injury, illness, death, or property damage resulting from the Activities.
- 4. Insurance.** Volunteer understands that, except as otherwise agreed to by Breadcoin in writing, Breadcoin does not carry or maintain health, medical, or disability insurance coverage for any volunteers of Breadcoin. Volunteer is expected and encouraged to obtain his or her own medical or health insurance coverage.
- 5. Photographic Release.** Volunteer hereby grants and conveys unto Breadcoin all right, title, and interest in any and all photographic images and video or audio recordings made by Breadcoin during Volunteer's Activities with Breadcoin, including, but not limited to, any royalties, proceeds, or other benefits derived from such photographs or recordings.
- 6. Confidential Information.** Volunteer agrees that any of Breadcoin's confidential information Volunteer has access to belongs to Breadcoin and Volunteer agrees to Breadcoin's restrictions on how to use it. "Confidential Information" means any Breadcoin information which by its nature or content is reasonably distinguishable as confidential or proprietary. Confidential Information may include, without limitation, intellectual property; projects or programs; technical or commercial affairs; and any trade secrets, including vendor, donor and partner lists. Confidential information does not include any information that (a) was already publicly known prior to disclosure or becomes publicly known after disclosure through no action or inaction of Volunteer's; (b) is already in Volunteer's possession, without confidentiality restrictions, at the time of disclosure; or (c) Volunteer rightfully obtained from a third party without a breach of that party's confidentiality restrictions. Volunteer agrees to only use Confidential Information for the purpose of performing the Services. Volunteer will not disclose Confidential Information to anyone other than authorized Breadcoin staff or those similarly authorized, nor will Volunteer use Breadcoin's Confidential Information for Volunteer's own benefit. Volunteer agrees to take reasonable measures to protect the secrecy of and avoid disclosure and unauthorized use of the Confidential Information.
- 7. Assignment of Intellectual Property Rights.** Volunteer hereby assigns to Breadcoin all existing and future intellectual property rights (patents, copyrights, trademarks (together with the goodwill symbolized thereby), trade secrets, know-how, and other confidential or proprietary information, and other intellectual property rights (collectively "Intellectual Property Rights")) and inventions arising from the Activities provided for Breadcoin during the term of this Release. Volunteer agrees promptly to execute all documents and do all acts as may, in the opinion of the Breadcoin, be necessary to give effect to this Section 7. Volunteer hereby irrevocably waives all moral rights to the extent permitted under the applicable legislation in the District of Columbia (and all similar rights in other jurisdictions) which Volunteer has or will have in any existing or future works.
- 8. Breadcoin Materials.** As between Volunteer and Breadcoin, Breadcoin is, and will remain, the sole and exclusive owner of all right, title, and interest in and to any documents, specifications, data, know-how, methodologies, software, and other materials provided to Volunteer by the Breadcoin ("Company Materials"), and all Intellectual Property Rights therein. Volunteer has no right or license to reproduce or use any Company Materials except solely during the term of this Agreement to the extent necessary to perform

Volunteer's obligations under this Agreement. All other rights in and to the Company Materials are expressly reserved by Breadcoin. Volunteer has no right or license to use the Breadcoin's trademarks, service marks, trade names, logos, symbols, or brand names.

9. PARENT/LEGAL GUARDIAN. If Volunteer is under 18 years old, the term "Volunteer" in this Release will include the Parent or Legal Guardian, as applicable, of Volunteer.

10. Other. Volunteer expressly agrees that this Release is intended to be as broad and inclusive as permitted by the laws of the District of Columbia, and that this Release shall be governed by and interpreted in accordance with the laws of the District of Columbia. Volunteer also agrees that in the event that any clause or provision of this Release shall be held to be invalid by any court of competent jurisdiction, the invalidity of such clause or provision shall not otherwise affect the remaining provisions of this Release which shall continue to be enforceable.
